 - **9.1.** The approval of the proposed Parish Adoptable Street Lighting scheme for the new Norwich Road development. Proposed Cllr G Moore seconded Cllr C Brooks and unanimously agreed.
 - **9.2.** The approval of the route of the foul water drainage pipe at the new Norwich Road development and the signed statement. Proposed Cllr G Moore seconded Cllr C Brooks and unanimously agreed.
- 10. To receive an update on the cycle path from Scole to Diss alongside A1066: Cllr Jones has met with Thelveton Estates and they are prepared to lease the land to the Parish Council.

Cllr Jones is investigating funding opportunities at this time it is not felt that the Social Infrastructure Fund is appropriate, it is repayable if the scheme does not go ahead. This should be considered when the project is a bit further forward. Cllr Jones has approached Civil Engineers for a guide to costs but is still awaiting a response.

Intention is to start with Phase I – land west of Dark Lane.

Cllr Jones to contact Thelveton Estates to agree 99 year Lease Path to be cut diagonally across to Diss Business Centre from halfway down Dark Lane.

Gap in hedge at Frenze Bridge will need a rail near the bridge to stop cyclist travelling in the A1066.

Budget 2021/22 for legal fees for Thelveton Estate and Scole Parish Council and other smaller associated costs.
